Don Krahmer Jr. is a member of the 1996 class of Forty Under 40 honorees.

He was 38 at the time and an attorney with Black Helterline in Portland. He was one of seven lawyers to be honored that year.

A graduate of Willamette University, both the Atkinson School of Management and the College of Law, Krahmer has journeyed through an array of professions and well-known Portland-area companies.

Between 1977 and 1991, he served as a legislative assistant to the Oregon Legislative Assembly, a commercial banker at U.S. Bancorp, an analyst at PacificCorp, manager of mergers and acquisitions at PacificCorp Financial Services, director of transactions at Pacific Harbor Capital, and CEO of the Atkinson Group.

He joined Black Helterline

in 1991, specializing in corporate and securities law, M&A and business organizations, and moved over to Schwabe Williamson & Wyatt in 2002.

His board and civic activity runs deep. Krahmer is a member of the Portland Business Alliance Board of Directors and a past board member of Greater Portland Inc. He has served on the Oregon Community Board of Directors for the Regence Group and chaired the audit and risk management board committee for Pacific Continental Bank.

Krahmer has also mentored dozens of young lawyers, helping to build a next-generation of diverse talent in law and business. Those efforts landed Krahmer on Portland's Monthly magazine's 2012 list of the 50 most influential Portlanders.

**Best advice for the 2022 class of Forty of 40:** "Be yourself and lead with your heart."

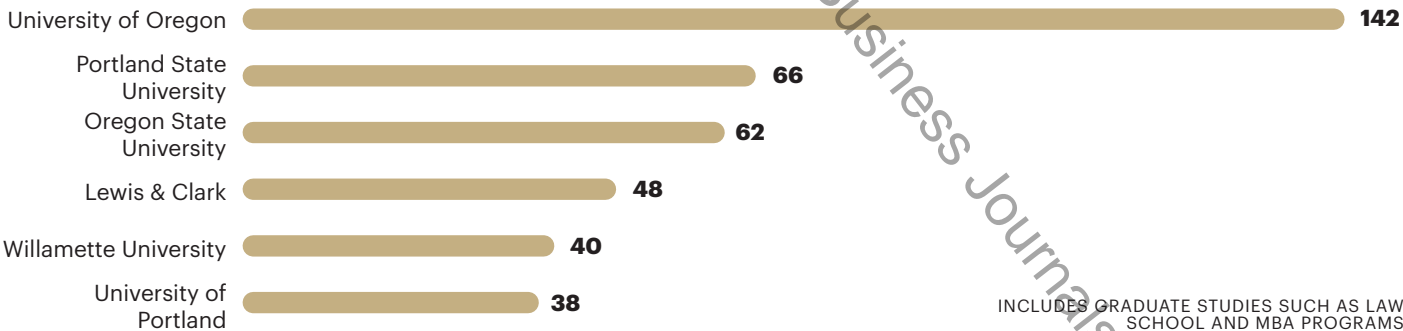

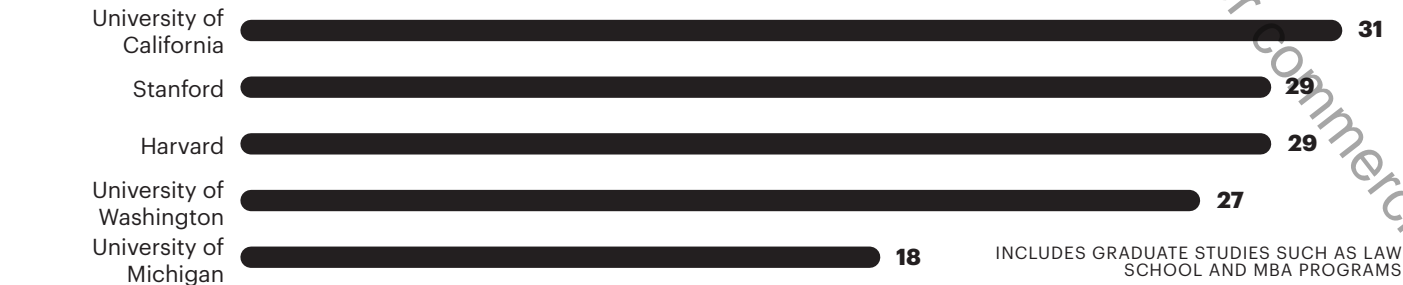

INCLUDES GRADUATE STUDIES SUCH AS LAW SCHOOL AND MBA PROGRAMS

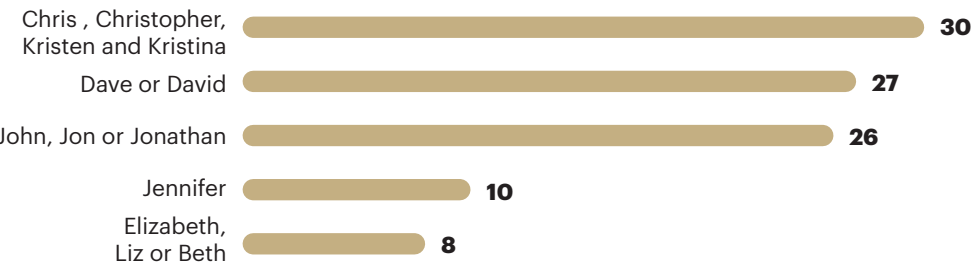
### MOST COMMON SCHOOLS | OUTSIDE OF OREGON

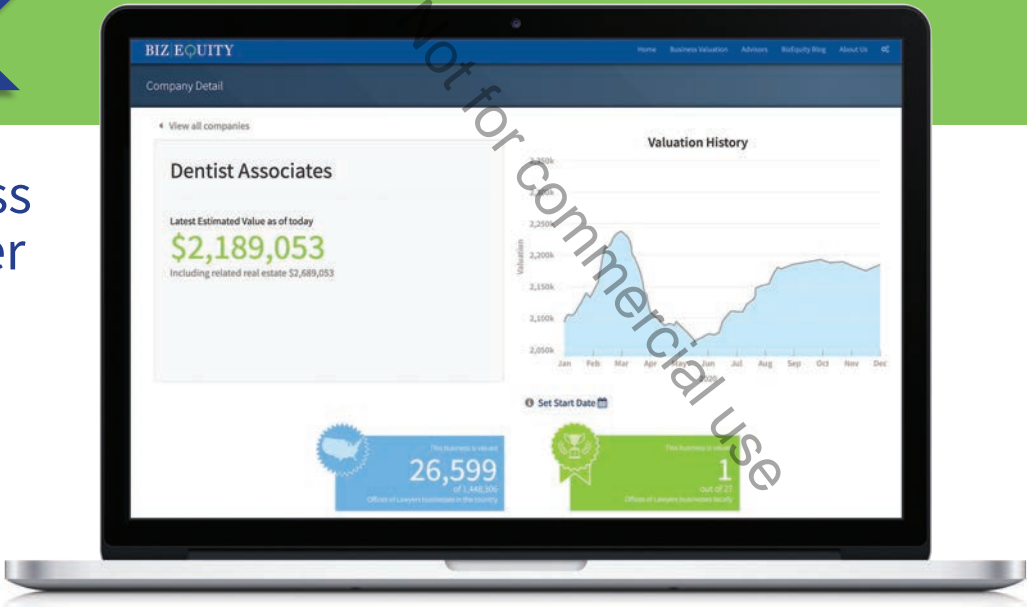
